- Meeting called to order→ introductions of Coco Lyons, DED Marketing Coordinator, and Ron Brown, County Attorney's office
- Minutes from May 10, 2011 meeting
 - Van Huyck→Motion to approve as written (Baer-second) (6-0 motion passed)
- Discussion of Evaluation Criteria with Ron Brown (County Attorney's Office)
 - o Mr. Brown gave his opinion that you just can't impose the evaluation criteria→ land that is in the AFD program are subject only to the conditions set forth in the AFD ordinance at the time districts renew
 - O Discussion ensued about the history of creating the new evaluation criteria, intent of the new evaluation criteria, etc.
 - ADAC asked Mr. Brown to work with AFD staff to rework the wording, etc. Mr. Brown agreed

- Kellner → Motion for staff to prepare action item where BOS adopts evaluation criteria as adopted on Jan. 31 in form as approved by the County Attorney (Kaufman second) (6-0 motion passed)
- ADAC questioned County Attorney about FOIA requirements concerning emails. AFD staff specifically brought up what constitutes a public meeting→
 - o Ron Brown replied that if an ADAC member sends an email to more than one other person on the ADAC it constitutes a public meeting
 - ADAC posed questions about different hypothetical situations and responses were given
- Staff update (discussion of written responses to issues raised at last ADAC meeting)
 - o FOIA (see above)
 - New Featherbed AFD outreach→ renewed in 2010→ 7 parcels ineligible for but were notified of eligibility for other districts→ because of the changes to the state code could apply for Featherbed in 2012
 - o Press Release for AFD changes distributed
 - Preliminary schedule for AFD reviews through 2019
 - Discussion ensued about whether not ADAC had voted to recommend 10-year terms for all AFD

 - Hapworth application for parcel MCPI: 432-28-7047 to the Middleburg East AFD
 - Kaufman motion to approve that Hapworth's application for interim additions (Baer second) motion passed (7-0)
 - Weeks application for parcel 666-40-6351 to Upperville AFD (Mr. Van Huyck abstained from consideration of the application)
 - Kellner motion to approve (Kaufman second) motion passed (6-0-1 Van Huyck abstained)
