"I move that the Economic Development Authority adjourn the closed session and reconvene the public meeting; and I further move that the Economic Development Authority certify that to the best of each member's knowledge (i) only public matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act and (ii) only such public business matters as were identified in the motion by which the closed session was convened, were heard, discussed or considered by the EDA during the closed session."

Both motions seconded by Mr. Mustafa. Both passed 4-0-3, Howard, Charron and Byers absent.
